Executive Summary

- There were seven homicides during the 3rd Quarter, one more than average and the same volume as the 3rd Quarter of 2022. One of the seven homicides in the 3rd Quarter of 2023 was domestic-motivated.
- Assaults increased 14% during the 3rd Quarter compared to the 5-year average as well as a volume 13% above volume in the 3rd Quarter of 2022. Most assault categories increased except for aggravated assault.
- There was an average volume of sexual offences in the 3rd Quarter and 6% higher volume compared to average for the year-to-date period. The increase in 2023 has been the result of an increase in both assaults with a weapon or causing bodily harm and Level 1 (common) sexual assaults.
- Robberies were almost 3% lower than average during the 3rd Quarter but approximately 30% above average year-to-date in 2023 driven primarily by an increase of person robberies.
- The presence of weapons in violent crime during the 3rd Quarter was higher than expected driven by increases across multiple weapon types. The largest increases occurred in physical force and other weapons (e.g. pepper spray or spitting) during the 3rd Quarter.
- The number of victims of domestic violence increased 4% from the 5-year average during the 3rd Quarter driven mostly by an increase of Level 2 (assault with weapon or causing bodily harm). Reports of domestic conflict increased 9% during the 3rd Quarter.
- Property crime volumes were 15% below the 5-year average in the 3rd Quarter with reductions across most Break & Enter types. There was a 24% decline of vehicle thefts in the 3rd Quarter as well.
- The number of young offenders identified was 13% above the 5-year average in the 3rd Quarter with a 16% increase in violent crime (driven mostly by a 33% increase in assaults) and a 19% increase in property crime (mostly break and enter as well as theft).
- Youth victims of violent crime increased slightly by almost 3% as compared to the 5-year average driven mostly by a 17% increase in assault victims and a 27% increase in miscellaneous person crime victims.
- The total number of police service requests during the 3rd Quarter was an average volume compared to the 5-year average. Police attended an average of 1,012 calls in the 3rd Quarter of 2023, almost 8% below the 5-year average.
- Citizen use of the online reporting system grew almost 20% during the 3rd Quarter compared to the 5-year average, with approximately 60 reports per day.
- An 8% reduction of disorder calls was noted in the 3rd Quarter of 2023 when compared to the 5-year average. Most disorder call types recorded reductions during the 3rd Quarter. Calls related to disturbances, unwanted guests and mental health concerns all notably increased. Disorder calls accounted for an average of 271 calls a day from the public.

REPORT NOTES

Most of the statistical data in this report is derived from the Calgary Police Service records management system (SENTRY). Disorder data is derived from the Computer aided Dispatch (CAD) system. Data is compiled by the Corporate Data and Analytics Team of the Bureau of Service & Community Support.

Reporting is based on the most serious offence in the incident. Please note that offences are assigned to the month in which the offence was *reported*, which is not necessarily the month the offence occurred. The reported date is the first point in time at which the police were notified of the offence and reporting lag may vary due to circumstances (these are typically property crimes where the victim did not report the offence until a later date, or was unaware of the loss until a later date, or late-reported sexual assaults). Also note that “attempted” offences are included in these totals. Violent crime, excluding robbery, is counted by the number of victims, using the most serious offence against the victim. Robbery, and all other crime, is counted by incident using the most serious offence in the incident. Of note, cases are often cleared months and sometimes years later. Consequently, clearance rates for previous years may appear to be much higher than those of the present year. Cases “cleared by charge” and those “cleared otherwise” are included in these clearance rate totals.

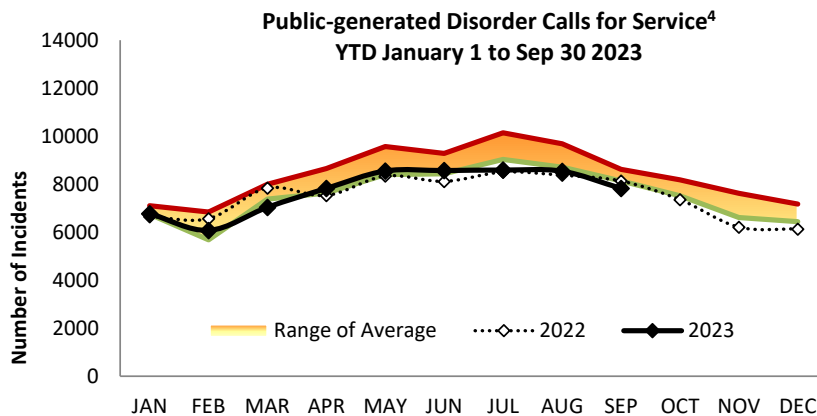

The implementation of the new provincial legislation (Provincial Administrative Penalties Act) has resulted in a significant reduction in impaired offences under the Criminal Code as most first time impaired drivers will be subject to only an IRS:FAIL (the specific administrative penalty under the Traffic Safety Act for criminal level impaired driving offences), unless the incident results in death or serious bodily harm or other significant aggravating factors in which case criminal charges should also be pursued.
