To: The City of Calgary Campaign finances and disclosure

While reviewing the Campaign finances and disclosures on elections website, I noticed a review engagement report is required for contributions of \$50,000 or more by a chartered professional accountant. I am a CPA, but I do not have a licenced practice. On February 28, 2022 at 9:56am, I called Campaign finances at 403-476-4100 (option 1) to get further detail and spoke with an agent named Kim. She did not have the answer to what type of review, but said I would have an answer within the next 7 days. Due to the time constraint, I have written this letter to show what I have done until I receive an answer from Campaign finances.

Review:

These are the steps I have taken in my review process:

- 1) Donations – I have taken the working papers provided by Doug Stevens (official Agent) taken a sample of donations and traced the transactions back to the bank transactions and cancelled cheques. I have confirmed the donations have been deposited into the bank account. I have reviewed the bank transactions for any other donations that have not been recorded.

I have reviewed a sample of the Donations from the working papers provided and confirmed no individual person made donations above \$5,000. I then went through donation deposit e-transfer (source documents) to ensure that no donor paid more than \$5,000.

- 2) Paypal transactions – I have taken the working papers provided by Doug Stevens (official Agent) and traced the paypal donations back to the deposits in the RBC bank statements. I then reviewed the bank transactions for any other deposits that were not recorded.
- 3) Expenses – I have reviewed the working papers provided to ensure all expenses have been recorded. I have taken a sample of expenses and traced them from the invoices back to the bank statements. I then took a sample of outgoing amounts from the bank statement and traced it back to expense invoices.

Based on my review, it appears that donations and expenses were used in line with Kim Tyers 2021 elections campaign.
