



Independent Practitioner's Review Engagement Report

To: Joel Laforest, Chief Financial Officer for Courtney Walcott for submission to the Chief Electoral Officer of Alberta in accordance with subsection 147.1 of the Local Authorities Election Act.

We have reviewed the accompanying Campaign Disclosure Statement and Financial Statement (the "Return") for the candidacy of Courtney Walcott, a candidate at the election of a member to serve as a city councillor held on the 18th day of October, 2021 in the electoral district of Calgary Ward 8, which comprises the Statement of Campaign Disclosure Statement and Financial Statement for the electoral campaign ending October 18, 2021.

This Return has been prepared by the CFO for the candidate based on the financial reporting provisions of subsection 147.3 & 147.4 of the Local Authorities Elections Act (the "Act") and the accounting guidelines issued by Elections Alberta.

Management's Responsibility for the Financial Statements

The CFO is responsible for the preparation and fair presentation of these financial statements in accordance with Elections Act and for such internal control as the directors determine necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioners Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements..

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that the financial information does not present fairly, in all material respects, the financial position of "the Return" of Courtney Walcott is prepared, in all material respects in accordance with the reporting provisions of section 147.3 & 147.4 of the *Local Authorities Elections Act* and the accounting guidelines issued by Elections Alberta.

As a result, the Return may not be suitable for another purpose. Our report is intended solely for the CFO, the candidate, and Elections Alberta, and should not be used by parties other than the CFO, the candidate or Elections Alberta.
