



Bearspaw South Feeder Main Improvements Project

REVISED - Upcoming Investigative Work, January 2026

Please note this is a update of the Construction Notice issued last week and includes additional details on parking restrictions

Background

The City is moving forward with the Bearspaw South Feeder Main (BSFM) Improvements Project, a critical step in strengthening Calgary's water system. We are implementing a revised plan that urgently expedites construction of a replacement for the Bearspaw South Feeder Main due to the critical condition of the current pipe. The project will add a parallel steel pipe of the same size as the existing BSFM. Over time, this new pipe will take over service from the current line. This work is an important investment in water infrastructure to support system reliability and reduce the risk of feeder main issues or failures.

As part of this project, The City will be completing early investigation work in your neighbourhood to better understand underground conditions. Work began on January 20 with geophysical investigation and will continue with additional geotechnical drilling and hydrovac activities starting January 26. More information on Stage B, 73 Street NW to 89 Street NW, will be shared as soon as possible. We appreciate your patience as we rapidly advance this work.

Work location

This investigation work is planned to take place along 34 Avenue NW between 88 Street NW and 71 Street NW. Work will begin near 87 Street NW and proceed east along 34 Avenue NW. See map on reverse for details.

Scope of work and schedule

Geotechnical drilling and hydrovac activities continue along 34 Avenue NW with additional hydrovac activities beginning on February 3, 2026

- Work includes borehole drilling and hydrovac activities to collect soil, groundwater information, and verify existing utility locations.
- Test holes will be drilled along 34 Avenue NW. See map on reverse for locations.
- Hydrovac locations will be throughout 34 Avenue NW.
- Schedules are subject to change.

Project benefits

This work is part of the broader Bearspaw South Feeder Main Improvements Project, which is being advanced quickly to support critical water infrastructure needs. When complete, this project will provide:

- Improved (new) water main infrastructure
- An extension on the lifespan of the water main serving your area, which may mitigate the need for impactful maintenance or repairs over time.
- Potential mitigation of water main breaks in your area.

Construction impacts

- Temporary, localized traffic controls will be in place near work zones.
- Rolling temporary parking bans on a block-to-block basis on both sides of 34 Ave N.W. between 87 St N.W. and 73 St N.W. begins February 2 for approximately 10 days. Each rolling ban would last for approximately three days before moving to another area. Vehicles that are not moved may be towed outside affected area.
- Additional traffic control measures, such as flag persons, may be required.

- Equipment in the area. All equipment is temporary and will be removed once testing is complete.


