



# CONTRACTOR'S AFE (MECHANICAL) PERMIT-Plans & Documents Requirements Checklist

Plans and documents approval is required prior to requesting for a rough-in Automatic Fire Extinguisher (AFE) inspection.

## REQUIRED PLANS/DOCUMENTS

The plans/documents submitted must meet all the requirements identified within HVAC Plans Submission, as required under the Alberta Building Code, 6.2.1.1. Good Engineering Practice.

- 1) Heating, ventilating and air-conditioning systems, including mechanical refrigeration equipment, shall be designed, constructed and installed in conformance with good engineering practice such as that described in, but not limited to
  - a) ASHRAE Handbooks and Standards
  - b) HRAI Digest
  - c) Hydronics Institute Manuals
  - d) NFPA Standards
  - e) SMACNA Manuals
  - f) Industrial Ventilation Manual published by the American Conference of Governmental Industrial Hygienists
  - g) CAN/CSA-B214 Installation Code for Hydronic Heating Systems
  - h) CAN/CSA-Z317.2 Special Requirements for Heating, Ventilation, and Air Conditioning (HVAC) Systems in Health Care Facilities
- 2) Where a health or safety hazard to a worker could result from the production or dissemination of airborne contaminants or from oxygen deficiency in the air, the ventilation systems serving these spaces shall conform to the Occupational Health and Safety Code.

## IMPORTANT

Plans and documents submitted must adhere to applicable codes, standards and regulations.

## INSTRUCTIONS

- All required plans and documents are submitted at the same time

### Note:

- As-Built Drawings for the AFE system may be submitted with the permit application, or alternately be on-site with a completed system verification when inspection is called.
- To align with regulatory requirements, all trade permit applications must include the owner's contact information. This ensures the owner receives important updates regarding inspections and job access codes. Applicants are responsible for obtaining and providing this information before applying.
- The required contact information must belong to the registered property owner, not just the person hiring the contractor.
