### **SECTION 1: Application resources**

- Review our **Digital document criteria** prior to submitting your application.
- Remove all personal information on plans.
- Plans/drawings must conform to the Alberta Building Code. Drawings stamped with "not for construction", "preliminary", or "for permit purposes only" are not acceptable

		1	Dimensions of all rooms		
		2	Purpose of all rooms/spaces (e.g., showroom, kitchen, bathroom, internal stairways)		
		3	The location of all walls, partitions, doorways, windows and other openings		
		4	Construction details of all walls and partitions including walls between adjacent tenants, washroom facilities, barrier-free accessibility		
		5	If a restaurant or drinking establishment, include a seating plan that clearly indicates the area (both indoor and outdoor) to which the public will have access for the consumption of food and/or beverages		
		6	Location of exits and access to exits		
		7	The finish of all floors, walls and ceilings		
		8	If applicable, the number of children under care or preschool facilities such as day care

The Development Authority or Safety Code Officer may require additional materials considered necessary to properly evaluate the proposed development (as stated in Part 2, Section 26(3) of Land Use Bylaw 1P2007, section 5(1) of Bylaw 39M2018 and the current National Building Code – Alberta Edition)

## **SECTION 4: Application prerequisites (where applicable)** Obtain an approved **Development Permit** — If the Land Use Bylaw requirements are not met. Your building permit plans must match the approved plans by the development authority. If insufficient information has been provided, a request for information will be sent out. A permit application may be refused if that information is not provided within 90 days of the request. Refunds will be processed as per our current fee schedule.
