## CAREFULLY READ AND SIGN AT THE BOTTOM TO ADHERE TO THE FOLLOWING:

- That I have read and understood the care instruction provided on the <u>National Farm Animal Care Council</u>, and I agree to adhere to generally accepted good husbandry practices.
- That the Urban Livestock licence does not exempt any person from the requirements of any Federal, Provincial or Municipal legislation, approval process, licensing or permitting regime, lease agreement, condominium bylaw, housing agreement or other.
- That I must ensure that the hens have adequate food and water; that I must provide adequate care when the hens are ill or wounded; that I must provide reasonable protection from injurious heat or cold; and that I must provide adequate shelter, ventilation, and space for the hens.
- That no livestock will be purchased or brought onto the property until an Urban Livestock licence is issued for the specific address.
- That livestock feces, feed, bedding or other materials must be disposed of in accordance with the City of Calgary Bylaws. Power washing onto the street or into a swale, having any material enter the storm drainage system or neighboring properties is strictly prohibited.
- That I have understood all requirements stipulated by The City of Calgary Planning and Development. I will fulfill these requirements before acquiring the livestock.
- If I am unable to care for the livestock or The City deems it unsuitable for urban living, I will be responsible for any additional cost incurred to relocate livestock. This releases The City from any financial obligations required to relocate the livestock.
- That as the City of Calgary has not completed an inspection of my property and the livestock housing prior to the approval of my Urban Livestock licence, I am subject to the inspection should it be required for any reason. I understand that if the housing is not consistent with what I submitted as part of my application, or not compliant with any City of Calgary bylaws at that time that my licence may be revoked and I will be responsible to relocate the livestock.
- DO NOT slaughter a hen within the City.
