



NOTICE OF INTENT

Special Tax Levy: Enhanced Landscape Maintenance

Attention homeowners: This letter is to advise property owners in Patterson that the Patterson Residents' Association ("PRA") wishes to continue with the Special Tax Levy for 2026 to support the community's Enhanced Landscape Maintenance (ELM) program. For 2026, the Special Tax Levy will be **\$107.04 per year** and will be added to your 2026 property tax bill. For comparison purposes, the 2025 Special Tax Levy was \$101.94 for the year. This is an annual cost, and all funds collected go directly back to your community to fund enhanced landscaping in accordance with the ELM Program.

Led by the volunteers of Patterson Residents' Association, the ELM Program is a community initiative that provides a higher level of landscape maintenance services than what the City of Calgary provides. The PRA is responsible for setting the Special Tax Levy rate, as well as managing the delivery of enhanced landscaping. The ELM Program allows for more grass cutting, supplying and planting of flowers, shrub maintenance, bed weeding and watering of Patterson Boulevard and Patterson Close. These enhancements are not possible without the Special Tax Levy. This Special Tax Levy was established in 1999, at the request of the Patterson Residents' Association, after completing a successful community wide petition acquiring the support of two-thirds (66.7%) of property owners who wanted to invest in enhanced landscaping along Patterson Boulevard and in Patterson Close. This community investment provides your community with well maintained and managed parks and open spaces along with positively impacting the image and economy of Calgary. As a property owner who is part of the Special Tax Levy in Patterson, you can initiate a petition to discontinue the levy. Parks Special Tax Levy Homeowner's Assistance Pilot Program

The City of Calgary is piloting a program to help low-income homeowners offset the 2026 Parks Special Tax Levy. This levy funds enhanced landscape maintenance and snow and ice control in community public spaces. The program is available to homeowners who:

- are listed on the property land title, and
- are approved through the City's Fair Entry program.

Fair Entry is the City's application process that provides eligible low-income residents with access to certain programs and services at a reduced cost. Eligibility is based on residency, income, and in some cases, age.

The Parks Special Tax Levy is available to Fair Entry members only. If enrolled in Fair Entry, please email ParksSTL@calgary.ca for instructions on how to apply for the Parks Special Tax Levy subsidy and submit your completed subsidy application and consent form by November 30, 2025.
